4 Paws' mission is to train service dogs to assist individuals with physical and hidden disabilities, including children with autism and seizures, with independent living. Training is recipient-specific for autism assistance, seizure assistance, mobility assistance, signal/hearing ear, and combinations thereof. 4 Paws for Ability service dogs qualify as durable medical equipment under the Americans with Disabilities Act of 1990 (ADA).

In addition to the cash expenses noted above, donations of time, including dog socialization, dog care, and training related to basic commands is vital to the accomplishment of 4 Paws' program.

Program revenues represent fees charged to individuals who adopt dogs that failed to complete the training program, as well as sales of promotional merchandise featuring the 4 Paws logo that serves to promote awareness of service dogs and their value to the community.

The temporary restrictions placed by donors on restricted donations typically stem from grants designated for specific portions of 4 Paws' mission, such as trainer salaries, costs to train dogs for clients from certain geographic areas, and the purchase of dog food and veterinary equipment. As 4 Paws recurring and frequent expenditures for these types of goods and services, the restrictions on such designated grants are typically met soon after receipt of the funds. At December 31, 2012, \$157,449 of 4 Paws' temporarily restricted net assets related to 4 Paws' program to benefit disabled veterans, and \$82,291 related to grants restricted for the benefit of disabled children in specific geographic areas.

The Form 990 is also provided to each voting member of the 4 Paws Board of Trustees. Each member of the Board of Trustees is given the opportunity to review and provide feedback on the form.

Form 990 Part VI, Section B, line 12: 4 Paws Board members affirm compliance with 4 Paws' written conflict of interest policy both verbally at the Board's annual onsite meeting at the 4 Paws facility in Xenia, Ohio, and in writing in response to an annual e-mail communication.

Form 990 Part VI, Section B, line 15: Compensation levels for each key position at 4 Paws are initially reviewed and voted upon by the Board of Trustees at the first regular meeting subsequent to the creation of the position, unless there is a need to expedite the hiring process, in which case a special meeting of the Board is held. In considering the proposed compensation levels for each position, the Board considers job market conditions, the duties of the job, and any specialized skill sets required, including consideration of the prevalence of those skill sets in Xenia, Ohio. The initial compensation levels for the Executive Director and Training Director positions were established through this process (both positions were unpaid for the first several years of 4 Paws' existence, and the Executive Director position has only been a paid position since 2008). Requests for modification to compensation levels of key employees are also brought before the Board of Trustees at a regular meeting and voted upon based on the job market conditions, the duties of the job, and any specialized skill sets required, including the prevalence of such skill sets in Xenia, Ohio. The Executive Director's responsibilities include reviewing all applicants, selecting applicants, helping applicants establish their fundraising efforts, purchasing dogs and supplies, record keeping, promoting the organization, coordinating approximately 200 volunteers, and managing a workforce of approximately 30 people at any given time. The Training Director's responsibilities include designing dog training curriculums to meet individual client needs, training service dogs, coordinating volunteer training and socialization programs at local prisons and universities, and training and supervising the dog training staff.
